Puppy described above is sold for the sum of \$2,000 for females and \$1800 for males and includes: Dew claw removal, tail docking, microchip, veterinarian exam and initial vaccinations and worming.
Acceptable payment to be made in full, minus \$500 deposit, at the time of pick-up or transport.

Buyer and breeder voluntarily enter into this agreement to include all the terms stated below. The terms are as follows:

Puppy is defined here to be a Vizsla puppy in good health at the time of the sale and embodies the characteristics of the Vizsla breed. This Puppy is purebred, and the litter has been registered with the AKC. Both parents have Excellent OFA rating, have had eye screening and have been deemed healthy by our veterinarian.

Puppy is sold with a Limited Registration. This does not prevent Buyer from doing anything with puppy except competing in the show ring or registering offspring with the AKC. Limited Registration may be lifted by Breeder at such time as Puppy is deemed to be of show quality and has an OFA (Orthopedic Foundation for Animals) or PennHIP certification of Excellent or Good and Elbow certification of Normal. Eyes must also be examined and found to be Normal by the Companion Animal Eye Registry. Any Puppy that does not meet these criteria is not eligible for an Unlimited Registration.

The AKC Registration papers for Puppy will be released to the Buyer at the time the Puppy is picked up or transported. It is recommended that any Puppy not intended for the show ring and subsequent breeding be spayed/neutered at the appropriate age.

The Breeder shall **NOT** be held responsible for the development of non-genetically derived disqualifying faults, diseases, or disorders. Some of these would include common puppy ailments such as worms and parasites, allergies and any viral or bacterial disease brought on by parasites, seizures, cancer, tooth extractions or any complication where there are no conclusive genetic tests available. The Buyer recognizes there are health issues that are not a result of genetics and the Breeder has done everything they can to provide you with a healthy, sound puppy. The Buyer agrees that the Breeder is not

responsible for the actions or safety of Puppy once it leaves the Breeder's possession. **Breeder is not liable for any costs that result from such actions.**

Health Guarantee

The Breeder guarantees the above described Puppy to be healthy at the time of sale. All Puppies will be vaccinated by the Breeder with the initial Parvovirus and Distemper vaccines. **To ensure the health and safety of the litter, all puppies will be vaccinated as described.** The Breeder will provide the Buyer with a Health Record and pertinent information detailing the treatment the Puppy has received under the Breeder's care and future care the Breeder recommends for the Puppy's health and wellbeing.

Breeder has done everything possible to produce healthy and sound puppies by breeding only dogs that are genetically tested and raising the puppies the best way possible regarding diet, exercise, socialization, and general care. If the Puppy is found to be other than healthy by the Buyer's veterinarian within 1 week of purchase, Puppy shall be returned to the Breeder immediately and purchase price refunded.

Buyer agrees that if at any time the Buyer can no longer take proper care of the Puppy, the Buyer will contact the Breeder and the Breeder will have the first choice to either: (a) take the Puppy back or (b) assist the Buyer in finding a suitable home for the Puppy.

This document constitutes the entire agreement between the Breeder and the Buyer with respect to this sale. Buyer's signature below indicates he/she has read, agrees with and does understand all the conditions of the Sales Agreement.
